



Employment by gender and education, age 24-64, 2000-2012





Maternity leave	16 weeks 100% salary	12.9 weeks 100% ordinary wages for the first 60 days of maternity leave, and maximum 1100 Euros for the remaining 30 days
Paternity leave	13 days 100% salary (4 weeks by 2007 law but not implemented due to budget restrictions)	3-5 days; 100% salary paid for 3 days, unpaid for 2 days
Parental leave	4 weeks unpaid	52 weeks for parents with children under 6, paid 40% of ordinary wages (maximum 810 Euros per month)
Leave of absence to look after children	For workers to look after their children or other dependent relatives. Maximum of 3 years unpaid. Social security contributions for old age and invalidity benefits are recognized during this leave	For workers to look after their children, parents or spouse on account of illness, accidents or old age Maximum 90 days unpaid
Right to time off work for breastfeeding	1 hour daily leave for the mother or the father until the child is 9 months old. 100% of salary	-
Reduction of working time	For workers with children under the age of 12 or older if disabled. Reduction can be for a maximum of 50% of working time with proportional salary reduction. Social security contributions remain 100% during first two years.	Working time reduction possible between 15 and 30 hours per week instead of using parental leave. Payments are provided in proportion to the reduced working hours
Universal Economic Allowance	For large families (3+children), single parents and mothers with disability of 65%. Single payment of 1000 Euros per year	-
Means-tested Economic Allowance	For families on low incomes (11 574 Euros/year; or 17 380.39 Euros for families with 3+children). Amount varies from 1000 to 6604 Euros/year depending on income and family circumstances	For single parent families with monthly income of less than 130% of the minimum living standard (children under 13 years old); 40-80 Euros per month For disabled children under 18 years old; 80-160 Euros per month For adopted children under 13 years old; 80 Euros per month (around 480 Euros for disabled children)
Childcare 0 to 3	Not universally provided 100 Euros/month to all working mothers with children under 3	Universally provided: all children aged 0 to 2 years old who are cared for at childcare facilities (replacement cost of childcare centre) Home care allowance for all families with children age 0 to 2; below 1 year old (160 Euros/month), 1 years old (120 Euros/month), 2 years old (80 Euros/month)
Pre-school 3-6	Universal provision. Near 100% schooling rates for full-time attendance	Universally provided: all children aged 3-5 for the centre-based childcare services (replacement cost of childcare centre) Home care allowance for all families with children 3-5 years old (80 Euros/month)
