#### **Project general description:**

The selected candidates will be invited to join the project "Policy recommendations to Maximise the beneficial Impact of Unexplored Mobilities in and beyond the European Union".

The PREMIUM\_EU project is funded by the European Research Executive Agency Call: HORIZON-CL2-2022-TRANSFORMATIONS-.

PREMIUM\_EU will develop a Regional Policy Dashboard (RPD) for policy makers in vulnerable regions to help them formulate policies to use the potential of mobility to enhance regional inclusive growth and wellbeing. It is an evidence based tool, where policy makers are offered tailor-made selections of policies that reflect the mobility and regional development profiles of their region. The Dashboard contains three modules, that contain state of the art EU-wide regional qualitative and quantitative information: a mobility module (MM), a regional development effects module (RDEM), and a policy module (PM).

## **Funcion description:**

The candidates will be invited to collaborate with the PI and will be given ample space to develop their own research agenda within the broad scope of the project's goals, which include:

- Conducting comparative cross-national research on Regional migration of Polish migrants in Spain.
- Documenting and analysing the extent policy, migration and regional inequalities.
- Exploring, cleaning and analysing the European regional mobility (Nuts3).

### **Requirements:**

- The researcher appointment is offered for social scientists with excellent analytical and writing skills who have completed their PhD and postdoctoral trainee.
- Aspiring candidates should have a solid background in Demography, Migration, Territorial analysis and/or closely related disciplines. Researchers interested in Migration, Demographic Metabolism, and Regional disparities are particularly encouraged to apply. Preference will be given to candidates with strong quantitative and also qualitative and writing skills.
- Aspiring candidates should have experience of working on EU funded projects.
- Experience with Qualitative Analyses programs, like Atlas.T or MaxQDA is required.
- Aspiring candidates should have good command on English.



#### **Conditions of employment:**

- The selected candidates will be invited to join the project in June of 2024. We offer a contract till the end of the project (31/March/2026) and the starting gross salary will be: €16.500 annually (18,5 h/weekly).
- Budget is available for the attendance of conferences, training and other research-related expenses. The candidates will collaborate with the PI and other members of the centre, to present their results in international conferences, and to publish in top social sciences journals. There are no teaching obligations.
