

#### PROVISIONAL RESOLUTION BY THE SELECTION COMMITTEE FOLLOWING A CALL BY THE CENTRE D'ESTUDIS DEMOGRÀFICS (CED) FOR APPLICANTS TO FILL ONE TEMPORARY POSITION IN THE AMBIT OF RESEARCH

In view of the resolution of March 24, 2025 by the director of the Centre d'Estudis Demogràfics, opening the selection process to fill two temporary positions in the ambit of research financed by the SINGLE project, Understanding the Demography and Stratification of Singlehood in Europe' (Grant number 101163333),

# ANNEX

## CRITERIA APPLIED

Three primary criteria will be considered when selecting candidates.

- 1. The ability and interest to co-develop new ways to measure and conceptualize Singlehood within demographic research and lead advanced demographic analysis of large-scale, complex, and multinational datasets. This ability can be evaluated based on past publications, work-in-progress, a motivation letter, and an interview.
- 2. Commitment to the topic of Singlehood and the two main leading frameworks – demography and stratification. This commitment can be expressed through previous work on the topic, as well as in the motivation letter and interview.
- 3. The capability of the person to attain competitive funding and grow as an independent researcher in the long term. This capability is primarily measured by the quantity and impact of previous publications and/or the capacity to publish in the near future, as well as the possibilities of attaining funding through competitions such as the Juan de la Cierva, Beatriu de Pinós, and Marie Skłodowska-Curie Actions (MSCA) calls.
